

Minutes of the Bid Opening Meeting held on 11th June 2020 for Expression of Interest (EOI) received from agencies/firms for Technical Support Units under National Tuberculosis Elimination Programme

For establishing a National Technical Support Unit (NTSU) and 9 State Technical Support Units (STSU) under the National Tuberculosis Elimination Programme (NTEP), a request for Expression of Interest (EOI) was published on Central Public Procurement Portal (CPPP) (e- publish) on 4th March 2020 with the last date for online submission of Bids on 25th March 2020. Pre-bid meeting for the same was held on 16th March 2020 at 11.00 in Nirman Bhawan, New Delhi and clarification / modification in EOI after Pre-bid queries were provided to the prospective bidders through e-mail and was also published in the NTEP website. However, due to Covid-19 situation and nationwide lockdown, the last date for EOI Bid submission was extended 4 times vide corrigendum to 15th April 2020, 11th May 2020, 27th May 2020 and finally to 8th June 2020. As per last corrigendum, the last date for EOI submission (online) was 8th June 2020 and hard copy submission date was 9th June 2020.

A Technical Committee for opening and evaluation of these EOI Bids was constituted with the approval of competent authority by MoHFW vide OM File No T-18012/06/2019-TB dated 13th March, 2020. The EOI bid opening date was 10th June 2020 at 11:00 am; however, Bid opening date was re-scheduled to 11th June 2020 at 11:00 am, due to technical constraints.

Accordingly, the meeting for opening of Expression of Interest (EOI) received from bidders with regard to shortlisting of Firms / Organizations to Establish 1(one) National Technical Support Unit (NTSU) in Delhi / NCR and State Technical Support Unit (STSU) in 9(nine) States was held under the Chairmanship of Dr. Sunil Gupta, Addl. DG on 11.06.2020 in room no. 528, C wing, Nirman Bhawan, New Delhi.


The meeting was attended by the following members:

At the outset, the Member Secretary welcomed all the committee members and apprised the committee of the objectives of the procurement proposal by the Central TB Division (CTD) and the details of the current EOI including the publishing date, pre-bid meeting and the corrigendum's issued.








Thereafter, in the presence of the committee members, authorized signatories of the procurement in CTD opened the EOI bids submitted by the agencies on the CPPP portal and handed over to the Chairperson. The hard copies received from all the bidders who submitted their proposals online were opened in presence of all Committee members. The summary of the bids received is as under;

1. Proposals have been received from 19 firms / organizations for the TSUs through CPPP portal (e-Procurement). However, hard copy along with processing fee was not received from 1 bidder namely IIDM. Hence, committee considered **IIDM EOI Bid as a non-responsive Bid.**
2. In addition, the hard copy from an organization named KMPG was received. However, there was no online EOI Bid submission on CPPP portal (e procurement) by KMPG. Hence, committee considered **KMPG EOI Bid as a non-responsive Bid.**
3. The committee found **only 18 out of 19 organizations as responsive bidders.**
4. EOI processing fee (Non-refundable) of Rs. 5,000/- (Rs. Five Thousand only) was submitted by all the responsive bidders.
5. The detailed observations (firm / organization wise) based on minimum criteria is placed at Annexure-1

The committee members decided to evaluate all proposals in their next meeting.

The meeting ended with vote of thanks to the Chair.
