- 3. The tender should be submitted in two parts i.e. Technical Bid and Financial Bid. - 5. The sealed quotations received within the stipulated time will be opened on same day at 11:30AM in Room no. 749-A wing, Nirman Bhawan. The bidders or their authorized representatives (if they so wish) may be present at the time of opening of the quotations.
- 6. Bidders, if wish may visit the premises of Ground floor, Jeevan Vihar building, Parliament Street, New Delhi during office hours.
- 7. Selection of bidder for the Procurement, Installation and Commissioning of air conditioning system will be done on the basis of Least Cost Selection method, following GFR guidelines.

b) Technical Requirements -

- 1) Only GST registered company/firm (s) are eligible to participate in this tender. Self-attested copy of GST registration to be submitted.
- 2) Self-attested copy of PAN card to be submitted.
- 3) Bidder should be registered / empanelled with any central Govt. organization / CPWD / PSUs/ BSNL / Railway. Self-attested copy of registration certificate of said organization to be submitted.
- 4) The bidder should have service center in Delhi/NCR area for providing prompt services during contract period / guarantee / warranty period for any defect / non-working or any issue pertaining to air conditioning system. A proof to the effect must be furnished.
- 5) The bidder should have experience of successfully completed similar works (at least two) in any central Govt. organization / CPWD / PSUs/ BSNL / Railway.

e) GENERAL TERMS AND CONDITIONS

- 1) The bid shall be valid for a period of 90 days from the date of opening of tender.
- 2) Tender inviting officer reserves the right to accept or reject any or all quotations without assigning any reason thereof and also do not bind himself / herself to accept the lowest tender.
- 3) The quoted prices shall be including all the taxes levied by statutory Govt. bodies.
- 4) The successful bidder to whom contract has been awarded has to complete the procurement & installation of air conditioning system within three (3) days from the date of award of contract letter.
- 5) No advance payment will be made.
- 6) The payment shall be made after successful completion and handing over of work in all respect. No interest will be payable on the delayed payments.
- 7) Warranty / Guarantee: Bidder must provide one (01) year comprehensive on-site warranty and it will be started from the date of the satisfactory installation / commissioning of goods.
- 8) Subletting of Work: The firm shall not assign or sublet the work/job or any part of it to any other person or party without having first obtained permission in writing of Central TB Division, which will be at liberty to refuse if thinks fit. The tender is not transferable. Only one tender shall be submitted by one tenderer.
- 9) Breach of Terms and Conditions: In case of breach of any terms and conditions as mentioned in tender, the Competent Authority, will have the right to reject the bid at any stage without assigning any reason thereof and nothing will be payable by Central TB Division.
- 10) Arithmetical errors shall be rectified on the following basis. If there is a discrepancy between the unit price and total price that is obtained multiplying the unit price and quantity, the unit price shall prevail and total price shall be corrected by the purchaser. If there is a discrepancy between words and figures, the amount in words shall prevail.
- 11) The selected vender should ensure that installed air conditioning system should provide temperature of 22 (+/-) 2°C and relative humidity (RH) between 45 to 55% for best human comfort during the entire contract period.
- f) Penalty Clause: The contract should be completed successfully as per delivery schedule prescribed in Clause No. e(4) failing which liquidated damage charges will be claimed @ 0.5% per day of the total cost of contract or up to maximum of 10% of contract value.
